EXERCISE OF THE RIGHTS RELATING TO PERSONAL DATA PROCESSING

(artt. 15-22 of UE Regulation 2016/679)

1. Access to personal data

(art. 15 of EU Regulation 2016/679)

 - the existence of automated decision-making, including profiling and meaningful information about the logic involved as well as the significance and the envisaged consequences of such processing for the data subject

2. Request of data rectification

(art. 16-18 of EU Regulation 2016/679)

The undersigned asks the Controller for the following operations (tick the requested boxes only):

- rectification and/or updating of personal data (art. 16 of EU Regulation 2016/679);
